CONTRACT AGREEMENT

WHEREAS, the Entity is desirous that the Contractor execute the COMPLETION OF UNIVERSITY SPORTS COMPLEX – LONG COURSE SWIMMING POOL (Reference No. 7495144) (hereinafter called "the Works") and the Entity has accepted the Bid for Fifty Three Million Three Hundred Sixty Five Thousand One Hundred Forty Pesos & 16/100 (Php53,365,140.16) by the Contractor for the execution and completion of such Works;

WHEREAS, the parties are well aware that this Agreement is time-bound which requires that the completion, inspection and payment of the Works shall be made not later than December 31, 2021 in accordance with Republic Act (R.A.) No. 11520, "An Act Extending the Availability of the 2020 Appropriations to December 31, 2021, Amending for the Purpose Setion 60 of the General Provision of Republic Act No. 11465 or the General Appropriations Act of Fiscal year 2020."

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulation of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Fifty Three Million Three Hundred Sixty Five Thousand One Hundred Forty Pesos 2 16/100 (Php53,365,140.16) or such other

The CATANDUANES STATE UNIVERSITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding and the requirement that the completion, inspection and payment of the Works shall be made not later than December 31, 2021 pursuant to RA 11520. In case of failure by the contractor to complete the project and submit the same for inspection on or before December 31, 2021, the performance security shall be forfeited and the contractor shall be liable for liquidated damages and blacklisted in accordance with the revised Implementing Rules and Regulations of R.A. 9184.
