THIS AGREEMENT made this

day of 20 between CATANDUANES STATE UNIVERSITY of Calatagan, Virac, Catanduanes represented by Dr. Patrick Alain T. Azanza, (hereinafter called "the Entity") and A3 GENERAL MERCHANDISE of Rawis, Virac, Catanduanes represented by Ms. Elvira S. Antonio (hereinafter called "the Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of IT Equipment, Supplies, Materials And Accessories for MIS Office (Project Reference No. 8522678) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Four Hundred Ninety Six Thousand Seven Hundred Twenty Four Pesos & 82/100 (Php496,724.82) (hereinafter called the "Contract Price").

 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - Supplemental or Bid Bulletins, if any iv.
 - Winning bidder's bid, including the Eligibility requirements, Technical and ii. Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- 111. Performance Security;
- Notice of Award of Contract and the Bidder's conforme thereto; and IV.
- Other contract documents that may be required by existing laws and/or the V. Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
