

CONTRACT AGREEMENT

APR 2 2 2022 THIS AGREEMENT made this day of between CATANDUANES STATE UNIVERSITY of Calatagan, Virac, Catanduanes represented by Dr. Patrick Alain T. Azanza, (hereinafter called "the Entity") and EURE'S PLANT NURSERY AND AGRI TRADING of Tumaway, Talisay, Batangas represented by Mr. Nelson A. Caraan (hereinafter called "the Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of Fruits Seedlings (Project Reference No. 8392916) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Seven Hundred Thirty Thousand Eight Hundred Fifty Pesos (Php730,850.00) (hereinafter called the "Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulation of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - Philippine Bidding Documents (PBDs);
 - Schedule Requirements; i.
 - ii. Technical Specifications;
 - General and Special Conditions of Contract; and iii.
 - Supplemental or Bid Bulletins, if any iv.
 - Winning bidder's bid, including the Eligibility requirements, Technical and 11. Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract and the Bidder's conforme thereto; and
- Other contract documents that may be required by existing laws and/or the

Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of <u>Seven Hundred Thirty Thousand Eight Hundred Fifty Pesos (Php730,850.00)</u> or such other sums as may be ascertained, **EURE'S PLANT NURSERY AND AGRI TRADING** agrees to provide the goods and services and to remedy defects therein in conformity will all respects of the provisions of the Contract in accordance with his/her/its Bid.
- 4. The **CATANDUANES STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
