**CONTRACT AGREEMENT** 

THIS AGREEMENT made this day of 20 2021 20 between CATANDUANES STATE UNIVERSITY, of Calatagan, Virac, Catanduanes represented by Dr. Patrick Alain T. Azanza, (hereinafter called "the Entity") and ANDSONS EDUCATIONAL RESOURCES, INC., of Blk. 22 Lot 2 Sicily St., Pallas Athena Executive Village, Anabu II-C, Imus City, Cavite, represented by Mr. Romeo O. Andrade (hereinafter called "the Supplier").

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly <u>Procurement of Laboratory Equipment and Supplies (Reference No. 7869766)</u> and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of <u>Nine Hundred Twenty Thousand Three Hundred Sixty Nine Pesos (Php920,369.00)</u> (hereinafter called the "Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulation of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of NINE HUNDRED TWENTY THOUSAND THREE HUNDRED SIXTY NINE PESOS (Php920,369.00) or such other sums as may be ascertained, ANDSONS EDUCATIONAL RESOURCES, INC. agrees to provide the goods and services and to remedy defects therein in conformity will all respects of the provisions of the Contract in accordance with his/her/its Bid.
- 4. The **CATANDUANES STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
