Delivery of the goods is required within 90 days after receipt of Purchase Order. Bidders should have completed, within two (2) years (*July 2019 to July 2021*) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Prospective Bidders may obtain further information from the Office of the BAC Secretariat, Catanduanes State University (CatSU) Main Campus, Calatagan, Virac, Catanduanes and inspect the Bidding Documents at the address given below during office hours, 8:00 to 12:00noon and 1:00 to 5:00PM (Monday-Friday).

A complete set of Bidding Documents may be acquired by interested Bidders (with Letter of Intent) from <u>August 2, 2021 to August 25, 2021</u> from the given address and website below and upon payment of the applicable fee for the Bidding Documents, , pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>Php500.00 (Five Hundred Pesos)</u>. Payment shall be made directly to the CatSU Cashiering Services The Procuring Entity shall allow the bidder to present its proof of payment for the fees, to be presented in person, by facsimile or through electronic means.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid Opening shall be on <u>August 25, 2021 (Wednesday), 3:00pm</u> at the Audio Visual Room, 3<sup>rd</sup> Floor Administration Building, Catanduanes State University, Virac, Catanduanes. Bids will be opened in the presence of the bidders' authorized representative who choose to attend the activity.
