Invitation to Bid for the

REPAIR/REHABILITATION/RETROFITTING/REPLACEMENT OF FOOD LABORATORY BUILDING

1. The *Catanduanes State University*, through the *General Appropriations Act FY 2021* intends to apply the sum of *Nine Million Nine Hundred Thousand Pesos (Php9,900,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for ***Repair/Rehabilitation/Retrofitting/Replacement of Food Laboratory Building***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Catanduanes State University Bids and Awards Committee (BAC) Secretariat* and inspect the Bidding Documents at the address given below from *9:00a.m. to 4:00p.m. (Mondays-Fridays)*.
5. A complete set of Bidding Documents may be acquired by interested bidders (with Letter of Intent) on **04 February 2021 (Thursday) to 23 February 2021 (Tuesday)** from **8:30AM to 4:30PM** from the given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php10,000.00)**. Payment shall be made directly to the CatSU Cashiering Services.

9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
10. Bid opening shall be on **February 24, 2021 (Wednesday) at 9:30am** at the *Audio Visual Room (AVR), 3rd Floor, Administration Building, Catanduanes State University, Virac, Catanduanes*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

Only representative/s of the bidder with the prescribed Authorization Letter/Special Power of Attorney shall be allowed to participate in the procurement activities of the stated project.

The *Catanduanes State University* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
