

INVITATION TO BID FOR THE PROCUREMENT OF AGRICULTURAL SUPPLIES

- The CATANDUANES STATE UNIVERSITY through the use of SBUI CY 2021 intends to apply the sum of <u>EIGHT HUNDRED FORTY-SEVEN THOUSAND FIVE HUNDRED</u> <u>PESOS ONLY (Php847,500.00)</u>, being the Approved Budget for the Contract (ABC) to payments under the contract for the PROCUREMENT OF AGRICULTURAL SUPPLIES/ <u>Identification Number 21-04-027</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CATANDUANES STATE UNIVERSITY now invites bids for the 2nd bidding of the above Procurement Project.

Delivery of goods is required within 30 days after receipt of Purchase Order. Bidders should have completed, within two (2) years (April 2019 to April 2021) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- Prospective Bidders may obtain further information from the Office of the BAC Secretariat, 3rd floor Admin. Bldg., Catanduanes State University (CatSU), Main Campus, Calatagan, Virac, Catanduanes and inspect the Bidding Documents at the address given below during office hours, 8:00 to 12:00AM and 1:00 to 5:00PM (Monday-Friday).
- 5. A complete set of Bidding Documents may be acquired by interested Bidders (with Letter of Intent) from <u>May 3, 2021 to May 26, 2021</u> from the given address and website below and upon payment of the applicable fee for the Bidding Documents, , pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>Php1,000.00 (One Thousand Pesos)</u>. Payment shall be made directly to the CatSU Cashiering Services The CatSU shall allow the bidder to present its proof of payment for the fees, to be presented in person, by facsimile or through electronic means.
- 6. The Catanduanes State University will <u>NOT</u> hold a Pre-Bid Conference on this particular procurement.
- Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, (ii) online or electronic submission as indicated below, and or (iii) both, on or before <u>May 26, 2021 (Wednesday), 2:00 o'clock P.M.</u>. Late bids shall not be accepted.



- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount state in **ITB** Clause 14.
- 9. Bid Opening shall be on <u>May 26, 2021 (Wednesday), 2:15pm</u> at the Audio Visual Room, 3rd Floor, Administration Building, Catanduanes State University, Virac, Catanduanes. Bids will be opened in the presence of the bidders' authorized representative who choose to attend the activity.

The Catanduanes State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
